In consideration of SUNRUNNER LOGISTICS Inc. extending credit to the applicant, the undersigned hereby agrees to the following terms and conditions:

1. SUNRUNNER LOGISTICS Inc. (TRANSPORTATION BROKER) shall not be liable for inability to deliver or delay in delivery resulting from fire, strike, flood, accident, war or the consequence of war, equipment break down, or any other cause beyond the BROKER'S control.
2. All claims for damaged goods, products must be made within 48 hours of delivery. Absence of such notice constitutes a waiver by shipper / receiver on all claims for damages.
3. SUNRUNNER LOGISTICS INC, at its option, may assess demurrage charges to the shipper / receiver for shipments detained for longer than 1 hour on less than truck load shipments and 2 hours for full truck load shipments at a rate of \$75/hour. As well any other costs incurred ie; warehouse, layover or charges resulting from border time incorrect customs documentation.
4. Acceptance of all or part of the material covered by this contract constitutes acceptance of the terms thereof by the customer.
5. This contract contains the entire agreement between the parties notwithstanding any contrary or inconsistent provisions that may be contained in the purchase order of the shipper / receiver. This condition cannot be altered except by written notation by SUNRUNNER LOGISTICS INC.
6. Interest of up to 2% per month or the maximum permitted by law will be charged on balances exceeding credit terms.
7. Customer understands that they will be responsible for any costs incurred in collecting outstanding amounts due and payable, including all attorney fees and court costs.
